## Description:

These journals were found in two different areas of the Olmsted Office. The diaries from 1895 to 1925, 1957, and 1959 to 1962 were stored in the upper vault.<sup>1</sup> All the other books were located in the printing room's closet (Rm. 204a). It appears that the Olmsted Brothers' secretaries maintained the diaries. Helen Bullard signed the inside front cover of the 1923 book, and initialed the 1924 diary. The journals, which were published by The Standard Diary Company, are present in four different models: *Standard Diary*, style numbers 565 and 566; *Daily Reminder*, style number 372; and *Year Book*, style number 708.

The diaries primarily provide a record of where the members of the firm were working on any given day. If a landscape architect is not designated as being "here," a job location or client is written next to his name. The diaries also note when an employee was ill or on vacation. Over the years, several of the firm partners died; their deaths are noted under the dates they occurred. In addition, the diaries contain the following information: the start date of new employees, the names (and sometimes, purpose) of visitors to the office, and the times of firm conferences. The journals were often used as appointment calendars, with tasks written in pencil under the dates that they were to be performed. Several of the diaries have notes written in the memoranda section. In general, the earlier diaries contain the most detailed information about the activity of the firm.
