Description:

Susanna Bixby Bryant founded Rancho Santa Ana Botanic Garden in 1927 on her property in Orange County, California. She was managing director of the institution until her death in 1946. The garden, which is still devoted to the native vegetation of California, was relocated to Claremont in the early 1950s when it became affiliated with Claremont College.¹

In 1929, Mrs. Bryant hired Olmsted Brothers to landscape the botanic garden. The firm produced plans for the project through 1939.² Frederick Law Olmsted, Jr. is listed as "Honorary Councillor" on the inside front cover of the Rancho Santa Ana Botanic Garden's *Occasional Papers*, and two of the semiannual reports are marked "FLO's personal copy."

These documents were found with a large group of periodicals in the planting department of the office wing. The collection primarily consists of reports issued by the Rancho Santa Ana Botanic Garden to its board of trustees, councilors, and staff. Each of the reports begins with contributions from the managing director, botanist, and superintendent, and ends with a survey of the garden's condition. Many of the reports include at least one photograph of a portion of the garden. The collection contains several other publications of the Rancho Santa Ana Botanic Garden: a series of *Informational Leaflets*, two volumes of *Occasional Papers*, one volume of *El Aliso*, and two booklets written by the garden's botanist, Carl B. Wolf. In addition to the Rancho Santo Ana Botanic Garden materials, there are two publications generated by other institutions: an issue of *Golden Gardens*, a magazine devoted to plants of California, and several annual reports of the Santa Barbara Botanic Garden.
