Description:

These files were located in one drawer of an historic oak filing cabinet in the upper drafting room of the office wing. The drawer was labeled "Specifs." The collection primarily consists of "ditto masters"¹ of specifications. Specifications present the terms of a contract for a landscape design project, setting out the proposed plans for construction work and planting. Also included in this collection are bidding instructions for contractors, plant lists, preliminary and general reports, and site studies. For the most part, the folders are arranged numerically by job number.

The collection does include several files that are devoted to non-job related materials. An interesting item in "Miscellaneous Ditto Masters, 1962-1965" (Box 1, Folder 5) is a copy of "Some Aspects of the Life and Times of the Olmsteds," a speech delivered by Joseph Hudak to the Brookline Historical Society in 1959. The file for the Hubbard Educational Trust (Box 1, Folder 1) primarily contains reports of meetings.² The four folders that have numbers with an "LR" prefix contain "Low-Rent Housing Bulletins" published by the Public Housing Administration.

Titles in brackets were given to materials that were stored, not in folders, but as loose items in the back of the file cabinet drawer. Items of note are a compilation of Christmas verses written by Olmsted employees between 1954 and 1959; resumes of the men who were firm partners in 1958; and a pamphlet published in 1902 by the Olmsted Brothers entitled "Statement as to Professional Methods and Charges," which describes in detail the working processes of the firm.

¹ Ditto masters are original documents designed to be reproduced by means of a spirit-duplicator machine. The text was typed on a sheet of paper backed with another sheet coated with a waxy dye. The pressure of typing imprinted the text in reverse on the verso of the top sheet. This "ditto master" was then wrapped around the drum of a spirit-duplicator machine, which soaked the paper with a thin layer of solvent to soften the dye. When the original was pressed (in the machine) against clean sheets of paper, multiple copies of the text were produced.

² The trust was founded in 1953 in memory of Henry Vincent Hubbard; its aim was to further education in the field of landscape architecture. Notes from the annual meeting in 1965 list 15 directors, including William Marquis, Charles W. Eliot, and Leon Zach. See also the *Hubbard Educational Trust Collection*, Frederick Law Olmsted National Historic Site, Brookline, Massachusetts.
