



## **Special Park Conditions**

### **Activity: Retail Sales**

#### **A. Authorized Services**

1. The holder of the Commercial Use Authorization (CUA) permitting the sale of visitor convenience items (VCIs) is required to have a current Cooperating Association Agreement between the Service and the holder. Participants must comply with conditions of seasonal area closures as signed and noted in park compendium.

#### **B. Permittee Certification**

1. VCIs will be sold in the area assigned in conjunction with the Cooperating Association Agreement for sales activities within the Area's visitor center(s).
  - a. Beaver Meadows Visitor Center
  - b. Fall River Visitor Center
  - c. Moraine Park Visitor Center
  - d. Park-n-Ride
  - e. Bear Lake Kiosk
  - f. Wild Basin Ranger Kiosk
  - g. Long's Peak Ranger Kiosk
  - h. Alpine Visitor Center
  - i. Kawuneeche Visitor Center

#### **C. Approved visitor conveniences items authorized for sale under this CUA are:**

1. Limited Photographic Supplies (film and/or disposable cameras, memory cards)
2. Sunscreen
3. Insect Repellent
4. Lip Balm with Sunscreen
5. Restop Waste Bag
6. Snack Items
7. Vinyl Ponchos
8. Bear Canisters
  - a. Wild Basin Ranger Kiosk
  - b. Long's Peak Ranger Kiosk
9. Pay Per View Telescopes
  - a. Alpine Visitor Center only
10. Bottled Water
  - a. Bear Lake Kiosk (when potable water is not available)
  - b. Park-n-Ride
  - c. Wild Basin Ranger Kiosk

- D. The holder of the CUA will provide an annual financial report from the sale of VCIs to the Superintendent by January 31 following each operating season. The report will define the holder's fiscal year and include the total gross receipts during that period.

#### **E. General Provisions**

1. All incidents involving overdue parties or accidents involving property damage or personal injury must be reported to park dispatch at (970) 586-1203 as soon as possible.
2. All advertisements/brochures which refer to Rocky Mountain National Park must be approved by the Superintendent prior to publication, distribution, or broadcasting. All such publications must include a statement that the operator is authorized by the National Park Service, U.S. Department of the Interior, to conduct services in Rocky Mountain National Park.

3. Prior to engaging in any commercial filming or still photography using model(s) (posed or on camera talent), set(s), or prop(s) that are not a part of the location's natural or cultural resources or administrative facilities consultation with the Commercial Services Office is required. This activity may be subject to a separate permit.
4. Violation of park regulations or the terms of this permit may result in the suspension of privileges granted by this permit and could lead to appropriate fines or citations, as well as non-renewal.
5. Proof of adequate general liability and automobile insurance coverage must be provided to the park prior to operating under this permit.
  - a. Commercial General Comprehensive Liability coverage is required in the amount of \$500,000 per person per accident.
  - b. Commercial Vehicle Insurance coverage is required for all owned, non-owned, and hired vehicles used by the Permittee who transport clients.
  - c. Minimum limits for Commercial Vehicle Insurance are 15 or fewer passengers, \$1,500,000 and 16 or more passengers, \$5,000,000. Rocky Mountain National Park must be listed as additional insurer.
