GENERAL:

The working relationships and responsibilities of the National Park Service (NPS) and the Wolf Trap Foundation for the Performing Arts (Foundation) are described in detail in a General Agreement between the two parties dated December 4, 1998, and expiring on October 1, 2018 (1998 Agreement). The 1998 Agreement was established for the purpose of the presentation and production of performing arts programs and certain related educational functions at Wolf Trap National Park for the Performing Arts (formerly, Wolf Trap Farm Park).

NPS and the Foundation have worked diligently to negotiate a new cooperative agreement over the past year. However, despite the continued good faith efforts by all parties, a new cooperative agreement will not be ready for review, approval, and signature by October 1, 2018. This modification is necessary because the negotiations for a new cooperative agreement with The Foundation are ongoing and additional time is required to reach an agreement. This modification extends the 1998 Agreement until April 30th, 2019 so that negotiations can continue towards a new cooperative agreement with the Foundation.

In order to ensure compliance with current law, this modification incorporates the required Title 2 Code of Federal Regulations (CFR) Part 200 Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards and all applicable Federal Laws that apply to Federal grants and cooperative agreements.

Because the 1998 Agreement between Department of Interior and Wolf Trap Foundation was not assigned an agreement number in the Financial and Business Management System (FBMS), agreement number P18AC01304 was created in FBMS as the official agreement number for the 1998 Agreement. The 1998 Agreement (P18AC01304) can be found as Attachment A to this modification.

MODIFICATION:

1. ARTICLE II – AUTHORITY, The following is modified:

The NPS enters into this modification pursuant to the authority contained in 54 U.S.C. § 100101 et seq., including 54 U.S.C. § 101702(c); 31 U.S.C. § 6305; 16 U.S.C. § 284d; and any other applicable authorities.

2. ARTICLE III – STATEMENT OF RESPONSIBILITIES-The following is added:

B. THE FOUNDATION AGREES TO:

For performance under this agreement, the regulations set forth in 2 CFR Part 200, supersedes OMB Circulars A-21 (2 CFR 220), A-87 (2 CFR 225), A-110, and A-122 (2 CFR 230); Circulars A-89, A-102, and A-133; and the guidance in Circular A-50 on Single Audit Act follow-up. The Foundation shall adhere to 2 CFR Part 200 in its entirety in addition to any terms and conditions of the master agreement not superseded by 2 CFR 200, as well as the terms and conditions as set forth in this modification. Unless otherwise specified herein, the terms and conditions as stated in the 1998 Agreement will continue in full force and effect. **In the event of a conflict between the terms of the 1998 Agreement and 2 CFR Part 200, relating to this modification, 2 CFR Part 200 shall take precedence.**

13. PROGRAM AND ADMISSION CHARGES AND POLICIES

3. ARTICLE IV – TERM OF AGREEMENT, The following is modified:

The Agreement will become effective from the date of final signature through April 30, 2019, unless terminated earlier per Article VIII of the 1998 Agreement.




