HISTORY

Since 1970, the preservation work at the park has been done largely by park staff. The documentation of work done by park staff, first and second generation Navajo masonry workers, is primarily visual. Stabilization reports continued to be produced by binding before and after photos and treatment forms together. The last bound report was in 1986. The complete set of Stabilization Reports (1933-1986) have been cataloged individually, and form two series in two collections: Coll 0021/001: RSU reports from 1933-1969; Coll 0022/001: Stabilization reports from 1970-2010.

The negatives are being entered at the item level in a park-developed Microsoft Access database. Extra prints will be mounted onto photocards and filed by site, room, then year. The Preservation Crew will then use this photo file for reference for yearly preservation work. As of 2016, the park stopped assignment of individual negative numbers to the digital images and began numbering them within the archival collection hierarchy in order to alleviate a separate number tracking system.

SERIES DESCRIPTIONS

SERIES I: STABILIZATION REPORTS, 1970-1990

During the 1970s, stabilization work shifted from the RSU, based on Globe, to both the park and the newly created Western Archaeological and Conservation Center in Tucson. Between 1970-1976, reports were produced by park staff (Cecil Werito) and various NPS archaeologists based at SWAC/WACC. By 1977, reports were produced by either park staff or regional staff from Santa Fe working for the park. Thus, there is considerable overlap with Collection 21, Records of the Ruin Stabilization Unit from 1970-76. The date of 1970 was arbitrarily chosen as the start for this collection because it was the first year Cecil Werito produced a report, marking the assumption of preservation duties by park staff. After 1986, records were compiled on a yearly basis, but not bound.

SERIES II: BACKFILL REPORTS, 1983-2005

Originally received from park in binders organized by site, years usually only spanning 2 or 3, the length of the project. Transferred out of binders into folders and document boxes using the same arrangement.

Arranged in chronological order

"Before" and "After" photos in plastic sleeves. "After" photos frequently taken a year or two from the time of the "Before" photo, even though it is the same project.

PRINTS OF PRESERVATION WORK

From 1970-1978, the preservation crew continued to use the 4x5" negative format used by the RSU crew, although in 1973-74, 35mm film was used. In 1979 the crew used a mix of 120mm and 35mm film. The 4x5" and the 1973-74 35mm negatives are stored in individual envelopes. The 120 and 35mm film from 1979 is stored in 3-ring albums.

Negative numbers were assigned in the early-mid 1990s to the images in the bound stabilization reports, in a series beginning with the 1938 report through the 1986 report. Thus, images in the volumes are in negative order number, but this order did not correspond in any way to the film strip negative order. Negative strips have been cut and rehoused in negative order number to facilitate retrieval.

During the switch of film formats, it appears that multiple cameras were used to record a single shot. Because the prints were numbered first, it is impossible to tell which format negative was used to produce the print. Thus, one print image may have both 120mm and 35mm negatives with the same number.

1970-1979: Negative numbers were assigned sequentially to prints in the bound stabilization reports. Because each stabilization action (usually on a room or kiva) has (ideally) both a before and after image, the two negatives associated with each action are from two time periods. Before and after images are often separated in date by months, and therefore come from different roles of film.

1980-1989: --

1990-2009: Organized into binders by year. Binders include contact sheets and negatives. Each binder has a list of negative number used for each site in the front.)

1970-1979: Arranged in negative number order, by format: 4x5 negatives are in envelopes in boxes and 120mm negatives are in a 3-ring album. 35mm negatives from 1973-1974 are housed in envelopes in boxes; 1979 35mm film is housed in an album. For 35mm negatives housed in albums, the location field will note this. All others are in the negative collection boxes.

Negatives were filed into NPS Negative Envelopes and Stabilization Record Envelopes. In the case of 35mm negatives in the main Negative Collection, because of the numbering system, one envelope might hold the before images, e.g., #67919 and 67921, while the following envelope will hold the after images, e.g., #67920 and 67922. So the numerical ordering system is not precise.

Includes three formats: up until 1979, 4x5" negatives were made. Starting in 1979, 120mm film was used. 35mm film was used in 1973 and 1974.

Information on each image has been entered into a park-created Access database. A few basic descriptive fields have been imported into ANCS+ at the item level. Negatives housed in envelopes have all pertinent information written on the envelope. For negatives in albums, information can be found in the bound volumes or in the Preservation Crew database and cardfile at the park (see below).

Prints have been pasted onto 5x8 index cards to create a file system for the Preservation crew. The prints are filed by: Site name/number, room, wall, year. This file system is maintained in the Cultural Resources division offices at the park and is not considered part of the museum collection.

NB: Data entry for dimensions was defaulted to 4x5, and is inaccurate in many cases. The software does not allow global editing of the dimensions field, so corrections for 120mm and 35 mm film sizes were entered into the "Associated Materials" field.

SERIES VI: NON-PARK PRESERVATION RECORDS, 1987-2003

In November 1986, at the request of John Roney, BLM Albuquerque District archeologist and Peggy Gaudy, Farmington Resource Area archaeologist, Cecil Werito and Dabney Ford from the CCNHP stabilization program assessed the stabilization needs of Twin Angels Pueblo. Based on the scope of work provided by Werito and Ford, the BLM archeologists prepared the Interagency Agreement No. NM-910-IA-003. The pueblo is under the management of the BLM and is part of the Chaco Protection Site System as established by Public Law 96-550 enacted in 1980.
