Attached for your review and signature is the 2024 Compendium for Golden Gate National Recreation Area (park). The 2024 Compendium includes the following revisions, additions and deletions:

- Page 3, **Definitions:** Commercial Use Authorization definition updated.
- Page 4, **Definitions:** Text changed from "Unmanned Aircraft" to "Uncrewed Aircraft" per new policy memorandum.
- Page 6, **Day Use:** Point Bonita Light House open hours updated.
- Page 7, **Parking:** Headlands Institute removed from text.
- Page 7, **Parking:** Parking fees updated to: Seven (7) days per week \$3 per hour, or \$10 per day, from 8 a.m. to 6 p.m.
- Page 8, **Parking:** Reserved valet parking time changed from midnight to 6am per new lease with SLE.
- Page 9, **Uncrewed Aircraft System (UAS):** Acronym name changed from "Unmanned" to "Uncrewed" per new policy memorandum.
- Page 11, **Closures:** Presidio water treatment plant removed from text, not under NPS jurisdiction.
- Page 17, **Permitting:** Commercial Carriers, Outdoor Fitness, Guided Services and Commercial Dog Walking removed from section as they are no longer permits, they are now Commercial Use Authorizations.
- Page 17 & 29, **Permitting:** "Commercial Photography/Filming" language has been changed to "Commercial Filming/Still Photography" to align with updated NPS-wide policy.

- Page 28, **Recreation Fees:** "36 CFR Part 71" language updated to "16 USC 6802" to better align with FLREA authority.
- Page 29, **Special Events Weddings, and Ceremonies:** Other activities for which a special park use permit fee is charged. Text has been moved under this section. Specific USC references have been added to each bullet point outlining individual authority.
- Page 31, **Demonstrations:** Lower Ft. Mason Building A removed as 1st Amendment location, the area is not within NPS managed lands.
- Pages 38-39, **Commercial and Private Operations:** Commercial Dog Walking, Outdoor Fitness and Guided Services added to this section as Commercial Use Authorizations.

Once the Compendium is signed, the park will provide notice of these changes to the public in accordance with 36 C.F.R. §1.7.
