










## Exhibit 5 Trail Restrictions Oakwood Valley



## Exhibit 13 Site Closures and Trail Restrictions Lands End/Fort Miley/Sutro Heights




#### Exhibit 14 Site Closures and Trail Restrictions Crissy Field






## Exhibit 15 Site Closures and Trail Restrictions Milagra Ridge









Exhibit 23 Regulations for Electric Bikes(E-bikes) Fort Mason








### Exhibit 25 Regulations for Electric Bikes(E-bikes) Milagra Ridge, Mori Point and Sweeney Ridge



#### Exhibit 26 Regulations for Electric Bikes(E-bikes) Rancho Corral de Tierra






#### Exhibit 27 Regulations for Pet Management Fort Cronkhite/Rodeo Beach









#### Exhibit 28B Regulations for Pet Management Redwood Creek






## Exhibit 29 Regulations for Pet Management Oakwood Valley






#### Exhibit 30 Regulations for Pet Management Homestead Valley






# Exhibit 31A Regulations for Pet Management Rodeo Valley












Exhibit 34B Regulations for Pet Management Fort Funston Admin Area




### Exhibit 41 Regulations for Pet Management Sweeney Ridge








## Exhibit 44 Regulations for Pet Management Rancho Corral de Tierra




Exhibit 47 Regulations for Horses and Pack Animals Northern Marin





Exhibit 50 Regulations for Horses and Pack Animals Rancho Corral de Tierra




# Exhibit 51 Regulations for Horses and Pack Animals Phleger Estate





# Exhibit 52A First Amendment Area Fort Point & Crissy Field




# Exhibit 52B First Amendment Area Alcatraz Island







### Exhibit 60 Regulations for Bicycles Lands End and Fort Funston




### Exhibit 61 Regulations for Bicycles Milagra Ridge, Mori Point and Sweeney Ridge
