

NORTH PARKWAY REHABILITATION PARK OVERVIEW

PARK PURPOSE


- Scenic roadway honoring the nation's first president
- Protects and preserves
 cultural and natural
 resources
- Comprehensive system of parks, parkways, and recreational areas surrounding the nation's capital.



UNIQUE ATTRIBUTES

- Great Falls to Mount Vernon, includes the Clara Barton Parkway
- Designed for recreational driving
- Listed on the National Register of Historic
 Places
- Links sites that commemorate important episodes in American history
- Preserves habitat for local wildlife
- More than a parkway!

SIGNIFICANT PARK RESOURCES

- Indigenous peoples including Algonquin, Iroquois, and Siouan
- Great Falls and the Mather Gorge
- > Arlington House, The Robert E. Lee Memorial
- More than 7,300 acres, over 100 threatened and endangered species
- Turkey Run biodiversity
- More than two dozen associated sites

NORTH PARKWAY REHABILITATION PROJECT OVERVIEW

GREAT AMERICAN OUTDOORS ACT

- North parkway section opened in 1962
- No major rehabilitation since opening
- Approximately 70,000 vehicles a day
- Great American Outdoors Act:
 - Revenue from energy development to provide up to \$1.9 billion a year for five years
 - Funds to be used to meet maintenance needs for critical facilities and infrastructure.



1. Invest in Essential Infrastructure

Investments will address infrastructure and facilities that have the greatest condition deficiencies. The NPS must continue to meet the needs and expectations of visitors while supporting their health and safety. To do this, we will focus on modernizing the critical infrastructure visitors rely on to enjoy their parks. Investments will include water systems, wastewater systems, electrical systems.



2. Restore America's National Park Roadways

The NPS will restore America's iconic scenic roadways that are in disrepair or have exceeded their design life. These roads require large scale projects to restore them to good condition. Investments will be focused on paved roads, bridges, and tunnels.



3. Enhance Recreational Access

The NPS will promote a positive visitor experience by improving access and enhancing recreational opportunities. NPS intends to accomplish this through facility improvements such as upgrading campgrounds, improving trails, increasing waterfront access, and modernizing and rehabilitating high visitor use buildings.




4. Use Leveraging Opportunities to Reduce Long Term Operational Liabilities

Investments must result in operations and maintenance (O&M) efficiencies, cost avoidance, or leveraging of resources. For example, by investing in leasable facilities, the NPS can attract and grow partnership opportunities with both the private and public sector.

REHABILITATION PROJECT OVERVIEW

- Four-lane scenic historic parkway
- Approximately 7.6 miles of the roadway between Spout Run to Interstate 495/Capital Beltway
- Fairfax and Arlington Counties
- > 128 water drainage outlets along the project corridor
- 10 bridges spanning waterways or existing roadways



Replace asphalt pavement



Lengthen entrance/exit lanes at some interchanges



Redesign Route 123 interchange



Reconstruct stone walls and roadside barriers



Repair stormwater management systems



Rehabilitate historic overlooks and re-open historic parkway views

ROUTE 123/CHAIN BRIDGE ROAD TO DONALDSON RUN Fall 2023 – Fall 2025


DONALDSON RUN TO SPOUT RUN PARKWAY *Fall 2023 – Fall 2025*

CONSTRUCTION IMPACTS


- Anticipated start of construction: August 2022
- Temporary lane widening at from I-495 to Route 123






CULTURAL LANDSCAPE

- Footprint reduced
- Selective tree removal and future replanting
- Rehabilitation of cultural landscape
- Restoring vistas and viewsheds




TEMPORARY LANE WIDENING



- Temporary lane on the northbound side
- Milling machines, paving trucks, and other
 equipment will be used
- A barrier will be set for crew and motorist safety
- 3-lane configuration
- Public notification

BRIDGE CONSTRUCTION IMPACTS

- Bridge work at Pimmit Run
 and Glebe Road anticipated
 to begin August 2022
- Motorists will experience lane closures; most bridge work will occur under the bridge; it will not be visible to parkway visitors




