## ***HISTORY***

Visitor and Resource Protection (VRP) encompasses the history of protecting visitors and preserving resources at Haleakalā National Park. Park rangers in VRP protect the natural resources from the people, the people from the natural resources, and the people from the people. VRP rangers conduct search and rescue missions, provide EMS and fire services for the park, and help educate visitors on a daily basis. VRP also includes the Feral Animal Removal Management (FARM) division. Originally part of Natural Resource Management, FARM rangers work to protect the resources of Haleakalā National Park from invasive animals including goats, pigs, deer, and cattle. They remove animals that damage park resources and work to build fences to prevent the animals from getting to the valuable resources in the first place.

*DESCRIPTION* This collection contains records pertaining to visitor and resources protection at Haleakalā National Park. Materials include correspondence, news articles, field reports, timelines, maps, and drawings. These records serve as an administrative record of visitor and resource protection management conducted at Haleakalā National Park. The collection dates from 1931 to 2008. Some of the material is undated. The bulk of the material dates from 1980 to 1999. Records are kept as they relate to the natural and cultural resources in the park. All other records are preserved by the National Archives and Records Administration (NARA).

*ORGANIZATION* The collection is arranged into three series: Series 01: Feral Animal Removal Management, Series 02: Fire Management, and Series 03: Law Enforcement. Series 01 is arranged into four subseries: History, Animals, Fencing, and Hunting. History and Hunting are arranged chronologically. Animals are arranged alphabetically by feral animal. Fencing is arranged geographically by fence area. Series 02 and 03 are arranged chronologically. File unit numbers denote the location of materials and are assigned BOX.FOLDER.

*PROVENANCE* The materials in this collection were created by Hawaii National Park (pre-1961) and Haleakalā National Park (1961 to the present).
