This document, the *Finding Aid for the Lowell Industrial Development Company Records, 1937-1956 (bulk dates 1949-1951)* describes records created and maintained by the Company at their facilities in Lowell, Massachusetts. These records are now part of the archives of Lowell National Historical Park (LOWE). These records and those of other closely related Lowell industries were processed as part of a backlog cataloging project carried out by the Northeast Museum Services Center (NMSC) with FY08 Backlog Cataloging funds.

The catalogers would like to express their gratitude towards the staff of LOWE for their assistance in carrying out this work. INTRODUCTION

This finding aid describes the contents of the relatively small amount of extent records related to the Lowell Industrial Development Company (LIDC). Most of these records date from 1949 to 1951, although the company was formed twenty years earlier to convert vacant mill buildings into spaces to be leased. Boott Mills helped to found the company and eventually merged with it. Presumably Boott Mills staff stored these records with their materials in the records storage facilities for the Boott Mills and the Proprietors of the Locks and Canals on Merrimack River where Lowell National Historical Park (LOWE) curatorial staff salvaged them shortly before a move of the records in 1984. They form part of accession LOWE-111.

As part of a fiscal year 2008 project to catalog collections related to the Proprietors and their affiliated companies in the LOWE archives, the Northeast Museum Services Center (NMSC) transferred the collection to its Charlestown facilities. NMSC Archivist Margaret Welch cataloged and rehoused the collection under the direction of Regional Archivist David Vecchioli. Sara Wolf, Director, and Giles Parker, Deputy Director, administered the Center during this time. Backlog cataloging moneys funded this project.

- Description:* These records were created and maintained by the Lowell Industrial Development Company which specialized in leasing space and power in the former Massachusetts Mills buildings and other Lowell facilities. Specifications and proposals for hydroelectric machinery, employee time cards, real estate appraisals, and bank account documents are included in the records.
- Cross-references:* The Proprietors of the Locks & Canals Records, 1813-2008 (bulk dates 1890-1970) (LOWE 5058, various catalog numbers) holds General File 1030 "Lowell Industrial Development Company" (boxes 17-19). Series Descriptions

Series I. Financial

A. Machinery Purchase

The most extensive records remaining in this collection are those related to major purchases of equipment in the early 1950s. These records consist of job specifications and designs and the subsequent proposals from the bidding companies. The LIDC treasurer, at the time Louis Waldron, kept these files including his handwritten notes and the copies of graphs comparing the companies' bids. It should be noted that most of the proposals were rejected, and the designs are, in most cases, not the final version; the LIDC staff may have retained these files with rejected proposals for long-term reference purposes. (The Proprietors of the Locks and Canals on Merrimack River Records (LOWE 5058) holds boiler drawings from the 1948-1950 period).

The machinery included boilers and other steam-related equipment and elevators. Most proposals relate to potential upgrades in the newly acquired Assets Realization division of the company. The file code system appears to include the main job number, a letter, and the number of the individual drawing, i.e., 647-E-9. The middle letters could represent the following: "M" for machinery, "E" for electrical, and "S" for supplemental.

B. Customer Accounts

Meter sheets document the electric lighting, power, and steam supplied to LIDC customers. The sheets incidentally provide the client companies' names.

C. Bank Accounts

These 1931-1934 bank statements and checks are a fraction of those created for the LIDC.

Series II. Taxes

A cross-reference to a real estate appraisal made during a tax dispute with the City of Lowell in 1957 comprises this series.

Series III. Real Estate

The varied documents in this series describe the buildings of the former Massachusetts Mills complex. A notebook holds photographs of the mills and power houses and floor plans showing the spaces leased by the individual companies. The real estate appraisals give, in addition to detailed description of the property, an historical background. A list of client companies renting space is included.

IV. Miscellaneous

Individual items not clearly belonging to a series include brochures from the Lowell Development & Industrial Commission, the Lowell government agency promoting industry. A file labeled "LIDC Liquidation" and an untitled notebook relate to the 1956-1957 period when Boott Mills took over LIDC.

V. Oversize

These items are intellectually associated with the letter- and legal-size materials but are too large to be stored in standard legal-size folders and boxes.

PART 2:

CORPORATE HISTORY

Chronology

1956	13 July	Boott Mills and Northern Textiles merge; with the LIDC identity retained as the "L.I.D. Division" of Boott Mills.

Narrative

Due to a combination of factors -- nineteenth-century facilities unable to house heavier twentieth-century automated machinery, lower costs in the American South, transportation -- major textile companies failed or left Lowell by the 1920s. Local investors, confronted with the large complexes and their energy-generating capacities, rethought the use of these structures. The Lowell Industrial Development Company, formed by owners of the Boott Mill and the Merrimack Manufacturing Company, redeveloped the buildings into smaller spaces suitable for a variety of light manufacturing and offices. Its first acquisition in 1930 was the former Massachusetts Mills complex bought by the Prescott Company and later the Pepperell Manufacturing Company. Some structures were torn down, and the buildings, converted to multi-tenant use, were leased. The energy-generating capacity, developed with the Merrimack River flowage and supplemented by steam generators, was maintained and so heat, electricity, and process steam was produced and sold to tenants and other buyers.




Figure 1. Detail from LIDC brochure showing the Massachusetts Mills buildings, Box 7, Folder 1.

Many small firms such as Lowell Paper Box Company, Lorum Fiber Company, and Spindle City Athletic Clothing Company ran their operations from the main LIDC campus (see Fig. 1). The principle sources of income for LIDC were rent, power sales to Boott Mills and Merrimack Mills, and power and light sales to customers other than Boott and Merrimack. In 1948, LIDC purchased the Assets Realization Company which controlled former mill property on Market Street not contiguous to the LIDC campus. LIDC apparently upgraded the new "Assets Division" facilities' steam generating facilities in the early 1950s.

The Boott Mills initially held fifty percent interest in LIDC; after its sale to Northern Textiles in 1955, Boott bought the remaining LIDC shares. Boott Mills retained the old LIDC components as separate entities: the Boott Mills records into the 1980s indicate "Massachusetts Division" and "Assets Division." As the Boott Mills sold off the Massachusetts Mills and Assets Realization buildings, the Lowell Industrial Development Corporation's identity faded.
