National Park Service Seeks Additional Public Participation In National Mall Planning Efforts

Washington, D.C. – The National Mall & Memorial Parks is continuing its public planning process, which includes two federal processes—the National Environmental Policy Act (NEPA) and the National Historic Preservation Act (Section 106 process). Both Acts have a public involvement component.

The Section 106 process invites those members of the general public to become consulting parties that have legal, economic or other concerns about historic properties within the National Mall Plan study area. As announced in the Federal Register planning announcement of September 6, 2007, the National Mall Plan is addressing both the NEPA and Section 106 processes. The NPS invites continued public participation in the National Mall Plan and is seeking to identify organizations who want to consult in the Section 106 process. More than 5,000 public comments have already been received. These comments and any new, additional comments will be incorporated into the planning process.

The NPS seeks public comment about how to combine ideas before developing a preferred alternative, completing analysis and preparing a Draft National Mall Plan / Environmental Impact Statement (DEIS). This DEIS is expected to be published by summer of 2008. At that time there will be two months for public review and comment and NPS plans on holding meetings in several locations around the country. Locations and dates will be determined.

JANUARY 2008 ALTERNATIVES DISCUSSION MEETINGS FOR NATIONAL MALL PLAN

Planning meetings will be held January 8, 9, and 12 at the Old Post Office Tower, 1100 Pennsylvania Ave., N.W., Washington, D.C. All meetings will be held in room Mo9 on the Mezzanine level. All meetings will have displays of the alternatives, but will include a focused discussion on topics of interest. Meeting notes will be taken. The meeting on January 9 will focus specifically on historic preservation and section 106 consultations.
