







Planning Area



Elements of a General Management Plan

- Identifies resource conditions, visitor experiences, management, and development that best fulfill the park's purpose
- Direction for resource preservation and visitor use
- Includes a foundation statement, identification of important resources and values, and alternatives
- Guided by the National Environmental Policy Act (NEPA), which requires consideration of a full range of alternatives
- Decisions must be based on scientific information

How is the TPAP different from the GMPA?

- General Management Plan Amendment (GMPA) 2021
 - Addressed management of lands leased for ranching in Point Reyes and north district Golden Gate National Recreation Area and free-ranging tule elk in those areas

Tomales Point Area Plan (TPAP) 2024

- Addresses management of the Tomales
 Point area
 - No active ranching in this area of the park
 - No free-ranging tule elk in this area of the park

Recreational Activities at Tomales Point



Purpose and Need

The purpose of the plan is to establish the management direction at Tomales Point for protecting natural resources, preserving historical and cultural resources, preserving wilderness character, and improving visitor experience.

The *need* for this project arises from:

- Recent droughts that adversely affected the elk herd's habitat conditions.
- The effects of climate change and the need to adapt management strategies accordingly.
- The partnership between the NPS and the Federated Indians of Graton Rancheria to ensure collaboration on future management strategies.

Alternative A:

Continue Current Management (No Action)

- Continue current management, which has required waivers to NPS policy on wilderness and wildlife management.
- Tule elk would be managed as a confined herd and the elk fence would remain.
- Supplemental water infrastructure would remain in place and used as needed.
 - Pierce Ranch would remain a passive outdoor exhibit with employee housing.
 - Trail maintenance for the *Tomales Point* and McClures Beach trails remains unchanged.
- Boat-in overnight camping / day use would continue for beaches and coves along Tomales Bay, north of the elk fence.

Visitor Amenities

Unique Features of Alternative B:

- Remove existing elk fence
- Establish wildlife-friendly fencing to prevent cattle from entering the planning area
- Modify historic stock ponds that pose a hazard to wildlife
- Remove 12 elk exclusion fences from Wilderness

Alternative B: (continued) **NPS Preferred Alternative**

Features Common to Both Action Alternatives:

- Continue tule elk monitoring and disease surveillance
- Discontinue emergency supplemental actions for elk
- Use integrated pest management (IPM) for invasive plants
- Continue limited plant monitoring and stewardship
- Use prescribed fire to meet desired conditions of native plant communities

Alternative B: (continued)


Programmatic Actions within Alternative B:

- Preserve and adaptively reuse Pierce
 Ranch
- Add a spur trail to Tomales Bay overlook
- Formalize parking capacity and add vault toilets
- Perform minor trail reroutes and adaptive trail management
- Develop a location-based camping reservation system
- Update management zoning for Tomales
 Point Area

Proposed Management Zone: Tomales Point Point Reyes National Seashore Planning Area Wilderness Elk Fence Scenic Landscape Zone Pierce Point Road Development Zone Philip Burton Wilderness (land) Philip Burton Wilderness (water) Tomales

Management Zoning

- Scenic Landscape Zone
- Development Zone
- Wilderness Zone



Unique Features of Alternative C:

- Retain and maintain the elk fence
- Actively manage elk population, based on carrying capacity of habitat, including potential use of lethal removal
- Enhance up to eight naturally occurring springs and seeps for wildlife use
- Retain the 12 elk exclosures for vegetation monitoring projects

Alternative C: (continued)

Features Common to Both Action Alternatives:

- Continue tule elk monitoring and disease surveillance
- Discontinue emergency supplemental actions for elk
- Use integrated pest management (IPM) for invasive plants
- Continue limited plant monitoring and stewardship
- Use prescribed fire to meet desired conditions of native plant communities



Alternative C: (continued)

Programmatic Actions within Alternative C:

- Preserve and adaptively reuse Pierce Ranch
- Add a spur trail to Tomales Bay overlook
- Perform minor trail reroutes and adaptive management
- Develop a location-based camping reservation system
- Update management zoning for Tomales
 Point Area

Alternatives Considered but Dismissed

- Complete a park-wide tule elk management plan
- Cease lethal control of the elk population
- Bring additional elk into the park from other populations (i.e., translocation)
- Other means of controlling the elk population

Alternatives Considered but Dismissed cont.

- Eliminate pesticides, especially in Wilderness
- Enhance and restore habitat for special species
- Improve trail to McClures Beach
- Formalize access beyond Lower
 Pierce
- Expand interpretive signage and education
- Perform a visitor carrying capacity study

- Vegetation Communities
- Tule Elk and Black-tailed Deer
- Wilderness Character
- Water Resources and Wetlands
- Visitor Use and Experience
- Cultural Resources






