COMPANY HISTORY: GALE RESERVES

COMPANY "H", TWENTY-NINTH REGIMENT MISSISSIPPI VOLNTEERS INFANTRY, KNOWN BY THE UNIT NAME: GALE RESERVES, WAS ORGANIZED ON MARCH 25, 1862 AT SATARTIA, MISSISSIPPI. THE COMPANY WAS COMPOSED MOSTLY OF YOUNG MEN. ENLISTMENTS WERE FOR THE PERIOD OF THREE YEARS OR THE DURATION OF THE WAR. COMPANY "H" WAS THE LAST VOLUNTEER COMPANY RAISED IN YAZOO COUNTY, MISSISSIPPI. THE INITIAL ON ROLL COMPANY STRENGTH WAS 130 OFFICERS AND MEN. HOWEVER, THE OFFICIAL COMPILED CONFEDERATE MILITARY SERVICE RECORDS OF COMPANY MEMBERS ONLY NUMBER 94 OFFICERS AND MEN. SOME OF THE LATTER MEMBERS ENLISTED INTO THE COMPANY AT LATER DATES.

AFTER THE COMPANY WAS ACTIVATED INTO CONFEDERATE MILITARY SERVICE, IT WAS SENT TO A STATE OPERATED "CAMP OF INSTRUCTION" AT GRENADA, MISSISSIPPI, WHICH WAS ALSO A MILITARY SUPPLY DEPOT. THE COMPANY ALONG WITH NINE OTHER MISSISSIPPI COMPANIES WERE ORGANIZED INTO THE TWENTY-NINTH REGIMENT MISSISSIPPI VOLUNTEERS INFANTRY ON APRIL 11, 1862. EDWARD CARY WALTHALL WAS ELECTED AND COMMISSIONED COLONEL OF THE REGIMENT ON THE SAME DAY.

A COMPANY MUSTER ROLL, DATED OCTOBER 31, 1863, REPORTED THAT ONLY
20 OFFICERS AND MEN WERE PRESENT FOR DUTY ON THAT DATE. SHORTLY
THEREAFTER, ON NOV. 24, 1863, DURING THE BATTLE OF LOOKOUT
MOUNTAIN, ALSO KNOWN AS THE "BATTLE ABOVE THE CLOUDS", 2 OF THE
COMPANY'S MEN WERE KILLED AND 18 WERE CAPTURED. MANY RECORDS
BELONGING TO THE COMPANY WERE LOST OR DESTROYED.

THE REMNANTS OF THE COMPANY ARE THE ARMY OF TENNESSEE WERE
SUBSEQUENTLY SURRENDERED BY GEN. JOSEPH E. JOHNSTON TO GEN.
WILLIAM T. SHERMAN, ON APRIL 26, 1865, AT BENNETT'S FARMHOUSE, NEAR
DURHAM STATION, NORTH CAROLINA. THE COMPANY WAS OFFICIALLY
DISBANDED AFTER JOHNSTON'S MEN WERE PAROLED AT GREENSBORO,
NORTH CAROLINA ON MAY 3, 1865.
