Excerpt from a Letter Written by Warren D. Earhart

Private Warren D. Earhart, Company F, was one of a detail of 30 men of the regiment assigned to infirmary corps duty to bring off the wounded. Shortly after the battle, he wrote a letter to his father and mother:

The Sun Rose through the thin clouds that past [sic] over made Every thing Gloomy at this time the Cannons and Muskets kept up a continual roar the news now came that the 9th Texas had to try her hand at the Enemy all in good Spirits the word was forward we marched up in Short Distance of the Enemy we then fired on them Our gallant Col. Said Boys yander [sic] they are Charge them we then charged them and broke there [sic] lines here we lost Several men one of whom you all know J.[James] M. Byrd he Spoke a few words before he Died he Said that I am Ded [sic] but thank God I am Happy
