Resignation Letter May 1863 Camp near Murfreesboro, Tennesee [sic] May 18th 1863. **Col. C. Goddard. Assistant Adjt [sic] General**

Sir

I must respectfully tender my resignation of the position of Captain of Co. B. 9th Regt. Ky. Vols. Infy. [sic] on account of the entire loss of the sight of one eye, and the vision of the remaining eye is so impaired that I cannot see objects so as to distinguish them apart at a distance of three hundred yards, and therefore hope that my resignation may be accepted.

I have no government property in my possession at present.

I am not indebted to the Government of the United States for any thing. – There are no charges against me whatever to affect [sic] my pay. – I was paid last by Maj. Hazelton up to the thirty first of August 1862. I have never been absent without leave.

I am with my regiment at this time and will be till these papers are heard from.

Capt: [sic] Silas Clark of Co. B, 9th regt. Ky Vol Infy [sic] Having applied to me for a Certificate on which to base an Application for his Resignation

I Certify that I have Carefully Examined this Officer and find that from an injury received some years ago he lost the sight of the right Eye, Also that the sight of the left Eye has been failing for at least one year and in the month of February 1863 the left eye was injured Since the which time he has not been able to distinguish Objects at a distance so as to identify them thereby disqualifying him for the position of an Officer in the Army and would therefore recommend the Acceptance of his resignation.
