Invalid Pension Declaration DECLARATION FOR ORIGINAL INVALID PENSION.

TO BE EXECUTED BEFORE A COURT OF RECORD OR SOME OFFICER THEREOF HAVING CUSTODY OF ITS SEAL.

On this 25 day of March, A.D. one thousand eight hundred and seventy [blank] personally appeared before me, a clerk of the District, a court of record within and for the County and State aforesaid, James S Handlin aged 35 years, a resident of the county of Appanoose, county of [blank], State of Iowa, who, being duly sworn according to law, declares that he is the identical James S Handlin who was ENROLLED on the 21st day of February, 1862, in Company C of the 74th regiment of O.V.V.S., commanded by Captain John Q Hutchison and was honorably DISCHARGED at Louisville, Ky, on the 10th day of July, 1865; that his personal description is as follows: Age 35 years; height 5 feet 8<sup>1</sup>/<sub>2</sub> inches; complexion, fair; hair, light; eyes Blue That while a member of the organization aforesaid, in the service and in the lone of his duty at Stone [sic] River in the State of Tennessee on or about the 31st day of December, 1862, he [Here state name or nature of disease, or the location of wound or injury. If disabled by disease, state fully its causes; if by wound or injury, the precise manner in which received.] was wounded in head in line of battle Was also wounded in Right leg or thigh in the battle of Dalton Ga. in 1864. He is still troubled by wounds, and claims pension for them. Was treated by regimental Surgeon.

That he was treated in hospitals as follows: [Here state the names or numbers, and the localities of all hospitals in which treated, and the dates of treatment.] Genl. Field Hospital, Murfreesboro Tenn. and No. 8, Nashville, Tenn

That she is the widow of James S. Handlin who Enlisted February 21st 1862 and who reENLISTED [sic] February 28th, 1864, at [blank], under the name of James S. Handlin, in (Here state company and regiment, if in the Army; or vessel, if in the Navy) Company "C" 74 Regiment Ohio Infantry and was honorably DISCHARGED April 23rd 1864 and July 10th 1865, having served ninety days or more, or was discharged for, or died in service of the United States of a disability incurred in the service in the line of duty, during the CIVIL WAR, and who DIED September 19th, 1926, at his house in Lincoln Township, Appanoose County, Iowa
