Contracted rheumatism while on a long and hard march from Nashville [sic], TN to Shiloh to Pittsburgh Landing to Corinth, Miss, thence to Battle Creek Tenn. in pursuit of Bragg thru KY in 1862. Being in severe rain full [sic] on Sunday night about the 6th day of April 1862 without shelter or cover and remaining very wet and cold. That he has continued to suffer more or less during all the years with said rheumatism, it settling principally in my left hip where I was struck with a piece of shell while an [sic] engagement at Kenesaw [sic] Mountain. Was not treated at hospital for said rheumatism. He is now drawing pension on gun shot wound to left leg

Sir:

I have the honor to acknowledge the receipt from your Office of application for Pension No. 232.349, and to return it herewith, with such information as is furnished by the files of this Office.

It appears from the Rolls on file in this Office that Samuel Nesbit [sic] was enrolled on the 5th day of Sept., 1861, at Tiffin, in Co. K, 49 Regiment of Ohio Volunteers, to serve Three years or during the war, and mustered into service as a Private on the 9th day of Sept., 1861, at Tiffin O., in Co. K, 49 Regiment of Ohio Volunteers, to serve three years, or during the war. On the Muster Roll of Co. "H", (to which transferred) of that Regiment, for the months of Sept. and Oct., 1861, he is reported private, present for duty, and so reported to Oct 31st 1862. Nov and Dec. 1862 absent wounded in battle of Stone [sic] River Tenn. Dec 31st, 1862 and in Genl Hospl [sic] Murfreesboro Tenn. and so reported to April 30th 1863. May and June 1863 was sent to Ohio in June to be exchanged was Paroled Dec. 31st 1862. July and Aug. 1863 Captured and Paroled at Battle of Stone [sic] River now in Ohio, Sept and Oct. 1863 gives same report. Nov and Dec 1863, absent wounded at battle of Mission Ridge Nov. 25th 1863.
