THREE YEARS' SERVICE.

THIS Regiment was organized at Camp Toledo, O., September 5 and 6, 1862, to serve three years. It was mustered out of service June 27, 1865, in accordance with orders from the War Department.

THREE YEARS' SERVICE.

The Regiment, with the exception of Companies I and K, was organized at Chase and Zanesville, O., from October 10 to December 12, 1862. Company J, formerly a company of the 109th Regiment Ohio Infantry, was organized at Camp Dennison, O., December 1, 1862, and Company K at Urbana and Columbus, O., from December 8, 1863, to March 31, 1864, all to serve three years. It was mustered out of service July 6, 1865, in accordance with orders of the War Department.
