FIELD AND STAFF.

THREE YEARS' SERVICE.

This Regiment was organized at Camps Chase and Jackson, Ohio, from May 29 to June 17, 1861, to serve three years. It was mustered out by companies, at different dates, from June 17 to 24, 1864, by reason of expiration of term of service.
