THREE YEARS' SERVICE.

THIS Regiment was organized at Camp Dennison, Ohio, from July 17 to September 20, 1861, to serve for three years. The original members (except veterans) were mustered out October 10, 1864, by reason of expiration of term of service, and the veterans and recruits were transferred to the Eighteenth Veteran Infantry Regiment, October 31, 1864.
