THREE YEARS' SERVICE.

This Regiment was organized at Dayton, O., August 20, 1862, to serve three years. The members whose term of service would have expired previous to October 1, 1865, were mustered out June 8, 1865, in accordance with orders from the War Department, and the remaining members transferred to the Forty-first Regiment Ohio Infantry.
