Austin Sober and Spencer Sober, at Chardou Ohio, on the 14th day of August, 1862, in [crossed out] probably sworn in at Cleveland Ohio in the [Here state rank, companyt, and regiment in Military service, or vessel, if in Navy.] 105th Reg O.V.I. in Co. K, and served as privates. (and these were all the sons I had) in the service of the United States, Austin Sober died at Claridon Ohio while coming home on a sick furlough, on the second day of January, 1863, from the effects of Measles and Spencer Sober died at Murfreesboro Tenn. from the Effects of Measles Feb. 24th 1863 incurred at Murfreesboro some weeks previous to their deaths

That said sons left neither a widow, nor child under sixteen years of age, surviving. That she is without other PRESENT means of support than her own manual labor or the contributions of others not legally bound for her support. That she has never applied for a pension; the number of her application is [blank].
