U.S. Mr. J. Allan Porter ordered me to fill up the blanks in the affidavits at Lt Hestards' [sic] death. I can find no blanks in them to be filled that way, but can inform you that Lt Hestard was killed in battle Sept 2nd 1864.

Your favor of the 26th ultimo by J. Allen Porter (U.S.) is at hand and I am truly gratified to learn that there is a probability that I can yet get matters properly settled.

Enclosed please find the affidavits - (3) that were sent to me for signature executed and signed.

In regard to the Ordnance dropped from my last return, I will say that I do not intend to attempt to account for it but simply to <u>pay</u> for it. There was never a single article charged against the men on my [crossed out] the muster rolls of the Company. I will also fall short in <u>Quartermaster's Stores and Camp and Garrison Equippage [sic] [illegible]</u> but it is all to be deducted from my pay

I have made satisfactory settlements with the men I am Gentlemen very respectfully
