Know all men by these present, that I: Henry Wright of said County and State, do by these presents make, [illegible] and appoint Captain Hudgins of Tuscalousa County Ala my true and lawful Attorneys [illegible] and in my name to collect all monies that may in

any manner be due to my Son John F. Wright deceased, for his services as a soldier of the Confederate Army; hereby giving and granting unto my said Attorneys or either of them my full power in the premises as to the collecting and recouping for the same and I hereby bind myself my heirs and assigns by whatever my said Attorneys or either of them lawfully do in the premises just as effectually as if the same were done by myself in person. In testimony of all of which I hereunto set my hand and seal. This the 4th day of December 1862. Attest B. H. Williams, Judge of Probate.
