## USER AGREEMENT CONDITIONS

Users of images from the NPS History Collection agree to the conditions listed below.

- User agrees to obtain all intellectual property rights, including copyright, from the rights holder, if the rights holder is not the National Park Service. User must provide written proof of use rights before NPS will release images not within the public domain.
- User understands that the use of the image does not surrender NPS History Collections' or the National Park Service's right to use or grant others permission to use the image.
- User agrees to release and discharge the NPS History Collection and the National Park Service from any and all claims and demands arising out of, or in connection with, the use of the image(s), including without limitation any and all claims, with regard to intellectual rights, including copyright, privacy, publicity, libel, and related legal issues.
- User agrees that images cannot be altered without written permission from the NPS History Collection.
- User agrees to furnish the NPS History Collection with two complimentary copies of the publication/production.
- User agrees to pay all applicable costs in advance.
- Permission is for a one-time, non-exclusive use of the image(s).
- Permission is non-transferable. User agrees to prohibit third-party use of the image.

- Permission for print publications is for a single edition of the publication, in one language. Additional language editions, subsequent editions, and any related promotional use must be considered as separate requests.
