### **NHL Significance:**

- The Sampson-White Joiner Shop is the only known surviving purpose-built, eighteenth-century woodworking shop in its original location and with its fixtures intact.
- Criterion 1 for embodying the early American woodworking trades that helped to build the young United States.
- Criterion 4 as an exceptional example of an early American joiners' workshop, a distinct but rarely surviving architectural type.

#### **Integrity:**

- The Sampson-White Joiner Shop retains a remarkably high degree of integrity
- This shop is the only known survival of a purpose-built eighteenth-century wood worker's shop in the entire country.
- Contained within the unexpanded walls of the building are original workbenches, tool racks, and other fixtures, all surviving with a remarkably high degree of integrity.
- During the period of significance, the second shop owner, Joseph White, made alterations to the building to sustain his woodworking profession.
- White retained most of Sampson's earlier racks, benches, and other fixtures.
- The largest changes that occurred in the shop under White's tenure were the insertion of a lathe and the addition of a third work bench.
- After its use as a shop, the structure transitioned to storage, thus preserving its interior and exterior.
