HISTORY

1880s - 1950s – The Yellowstone Hospital, located in Mammoth, records births and deaths inside the park.

1916 – National Park Service created.

1916 – Soldiers who are members of the Yellowstone Park Detachment and desire to remain in the park are discharged from the Army and appointed rangers in the National Park Service.

1916 – Automobiles are permitted entrance to tour Yellowstone. The park sees a significant increase in automobile accidents, resulting in personal injury and death.

1917 – After complaints from the public and elected officials, soldiers return to duty at Yellowstone and the initial ranger force is dismissed from service.

1918 – The Army is finally and completely withdrawn from the park.

1919 – James McBride becomes Yellowstone’s first chief ranger.

1920s - Present– Yellowstone keeps individualized records of incidents and accidents inside the park.

1946 – The Federal Tort Claims Act is passed and the federal government sees an increase in citizen lawsuits for damages to property, person, and deaths occurring in the National Parks.

1960s– Construction of new Yellowstone Hospital at Lake.

1970 – The Stoneman Meadow Riot in Yosemite National Park spurs some of the first service wide reforms in law enforcement.

1972 – The grizzly mauling of Harry Walker and ensuing landmark tort claim case.

1973 – In response to the death of a ranger at Point Reyes National Seashore, new policies are created which require law enforcement rangers to be armed at all times, establish national standards for law enforcement training, and establish criteria for the delegation of law enforcement authority and the use of firearms and defensive equipment.

1976 – The Authorities Bill (16 USC 1a-6) codifies the statutory authority of the National Park Service to designate employees to maintain law and order and protect persons and property in the national parks. These powers included the ability to carry firearms, make arrests, execute warrants, and conduct investigations.

SCOPE AND CONTENT

DESCRIPTION Records pertaining to protection and safety, including law enforcement, emergency medical services (EMS), search and rescue (SAR) functions, and tort claims.

These records also include but are not limited to: visitor safety concerning wildlife, natural resources, and motor vehicle accidents, criminal activity prevention and investigation, ranger patrols, and park maintenance. Also included are records from the communication center, including emergency dispatches and radio traffic.

Researchers may find these records valuable on the following topics: the development and professionalization of law enforcement in the National Park Service, trends in visitor safety, especially regarding human and wildlife interactions, and changing concepts and perceptions of wilderness.

This collection is especially valuable due to its completeness and date span, ranging from the creation of the National Park Service to the present day. In addition, the length of time covered by this collection allows for longitudinal studies. Taken as a whole, these records document the transformation of the National Park Service's role in managing visitor safety and protection as well as the protection of the park's natural resources.

ORGANIZATION

Organized into six series:

Series I: Administrative Reports

Created by Chief Park Rangers and District Rangers detailing the everyday functions of the park.

Series II: Correspondence

Chief Ranger and Superintendent correspondence

- pertaining to law enforcement.
- Series III: Incident Files
Case Incident Reports created by law enforcement rangers to document various accidents, crimes, and fatalities.
- Series IV: Operations
Manuals, protocols, and regulations concerning law enforcement ranger operations and conduct.
- Series V: Law Enforcement Logbooks
Logbooks from ranger stations, Chief Ranger's office, and the Communications Center.
Communications Center records also include Case Incident Report registers and radio logs.
- Series VI: Patrol Cabin Logbooks
Ranger logbooks from backcountry patrol cabins.

Series I, II, IV, V, and VI retain their original order as arranged by the creating office. In most cases, this arrangement is thematic and chronological, with the exception of newly processed materials added to the end of these series. Photographs can be found in all series, and have been left in their original locations.

Series III has been rearranged by function of the records and then chronologically. The bulk of series III, the case incident reports, have also been rearranged chronologically, although the original order was reconstructed for the case incidents from 1973-1999 due to the uniform assignment of case incident numbers. Several maps and large photographs relating to search and rescue operations and federal tort claims, have been separated from their original location and placed in oversized housing. A separation sheet has been filed in each item's original location.

PROVENANCE

Transferred to the archives by various park offices and staff, primarily the park's law enforcement division, often as part of a larger group of records. This record group is accessioned by the National Archives and Records Administration (NARA) and placed on deposit at its affiliated repository, the Yellowstone National Park Archives. These records correspond to the NARA Record Group 79, Records of the National Park Service.

SERIES DESCRIPTIONS

I. Administrative Reports

This series contains the Chief Ranger's monthly reports, ranger annual and monthly reports, organizational charts, situational reports, and morning reports.

Chief Ranger's monthly narrative reports detail information compiled from all the ranger stations, sub-district rangers, and district rangers. Topics discussed include employees; forest fires; fishing; road, trail and fencing improvements; natural phenomena; visitors; wildlife; protection and care of game; arrests and violations of the law; ranger conferences including meeting minutes, notes, agendas, reports and presentations; annual and quarterly fiscal reports including search and rescue (1969-1998), the Chief Ranger also submitted annual reports (1940-1995) for inclusion in the Superintendent's annual reports.

Monthly ranger reports were created by district rangers and park rangers. Topics include: weather; special activities; inspections; accidents; personnel; complaints, research and observations; interpretive contacts; fish and game (wildlife) census; fish planting; trapping and hunting violations; fire protection; building and fence maintenance; trail condition surveys; public contact and use statistics; monthly meeting minutes and committee meeting notes; automobile traffic statistics (1966-1972); and study of traffic conditions. Reports on the Mount Washburn ski area are for 1941 only.

Organization charts show growth and change in the Ranger Division from 1964-2002. The division's hierarchy, grade, title and ranger's name are included in the charts.

Situational reports includes Communication Center statistics, boating and diving statistics; ski area narrative reports (1941), audits, firearms inventories (as assigned to individual rangers), and search and rescue statistics.

Morning reports (1970-1990) made by the Chief Ranger's office contain weather reports, road conditions, staffing reports, wildlife and geothermal concerns, training opportunities, and upcoming administrative deadlines. These were distributed internally, or for announcement by park dispatchers.

II. Correspondence

This series contains correspondence from the Chief Ranger's Office and the Superintendent's Office. Topics include: permits (hunting, firearms, boating, vehicles, fishing, over-snow vehicles, backcountry use); visitor letters (compliments and complaints); accident, injury and theft reports; violations of regulations; employment applications; fugitive notices; statistical reports on vehicle use and public use; annual reports on threats to the park; zoning; regulations; jurisdiction; horse and mule use; staff housing rates and use; law enforcement activity; tort claims and judicial activity; staff instructions and orders; organizational goals

and objectives; training; agreements; lost and found; safety; concessions; mining; land use; grazing; and grizzly bear and wildlife management.

III. Incident Files

The bulk of this series includes incident reports from the 1920s to the 2000s that contain significant information from motor vehicle accidents, criminal and animal incidents, as well as fatalities. Also included are federal tort claims, boards of inquiry, bond logs, violation notices, birth and death records, arrest records, warrants, and court orders.

Indices are provided for the years 1941-1953, 1973-1989 and 1995-1999 and can be found at the beginning of the series.

Case incidents encompass a wide variety of emergency services inside the park, and are formatted into two categories: case incident *files* from the 1920s to the early 1970s and case incident *reports* from around 1972 to present. This is significant because it allowed the National Park Service to have a uniform reporting system through the park's Communications Center in Mammoth, instead of case incident files being reported through the Chief Ranger's Office and Superintendent's Office annual reports.

Early case incident files from 1926-1929 include special reports on attempts to reactivate Handkerchief Thermal Pool and the death of two beavers by falling off Tower Falls, as well as files on National Park Service and concessioner employee injuries. The main types of case incidents throughout the date span include bear attacks, bison gorings, heart attacks, health issues related to elevation and exertion, falls, drownings, suicides, murders, rapes, domestic disputes, poaching incidents, thermal burns, work related injuries, structural fires, wild fires, security alarms, alcohol and drug related crimes, disorderly conduct, larceny, protests, vehicle accidents and fatalities, search and rescue efforts, and law enforcement assistance to other agencies.

Case Incident Reports often include both Emergency Medical Service reports filed by the first responders, as well as reports from rangers, and if relevant, statements from witnesses. Of special note are the files related to the plane crashes of a B-17 and B-47, and subsequent retrieval efforts in the 1990s.

The tort files range from the mid-1950s until the mid-2000s, and encompass claims for damages to person and property. Claimants include both visitors to the park as well as park employees. Major tort files of note include the Harry Walker case of 1972, the Andy Boldizar case of 2001, and the Lance Buschi case of 2004.

Birth and Death records span from the late 1920s until the 1970s. Although these records state Mammoth Hospital or Lake Hospital (after 1963) as the location of birth or death, certificates were issued by Health Departments in Wyoming and Montana.

IV. Operations

This series contains memoranda, manuals, and protocols regarding operations and conduct of law enforcement, as well as EMS and medical operations and contracts. Ranger manuals and ranger station manuals document official protocol for daily operations. The regulations manuals define special and general law enforcement regulations within the park. The series also contains annual group photographs of Yellowstone law enforcement rangers.

V. Law Enforcement Logbooks

This series contains logbooks from ranger stations, the Chief Ranger's Office, and the Communication Center.

Ranger station logbooks include weather conditions, station maintenance reports, incidents and injuries, wildlife sightings, fire lookout and protection, station opening and closing procedures, park visitor contacts, fee collection, and law enforcement activities. Of note, the logbooks provide ranger accounts of the 1988 fire season. Also included are scrapbooks from the Old Faithful Ranger Station, 1975-1990.

The daily logs of the Chief Ranger's Office include daily weather conditions, travel by rangers within the park, fire reports, law enforcement activities (investigations, arrests, and court proceedings), maintenance and repairs, staffing and duty assignments, and snow removal reports.

Communication Center logbooks document the park's daily radio and telephone communications. Topics include weather conditions and forecasts, visitor communications and incoming phone calls, road reports; road closures, motor vehicle accidents, medical emergencies, aircraft within the park, search and rescue activities, case incident registers, incarceration registers, and geothermal activity.

Of special note are the daily diaries of Chief Ranger George Baggle, dated 1930-1934.

VI. Patrol Cabin Logbooks

This series contains logbooks from the backcountry patrol cabins throughout the park.

The entries include cabin chores (splitting wood, trash removal, cleaning, cooking, and cabin repairs), lists of supplies, weather conditions, animal sightings and interactions, visitor registers, firefighting efforts, reports of earthquakes, recreational activities such as hiking, fishing, boating, and trail crew activities.
